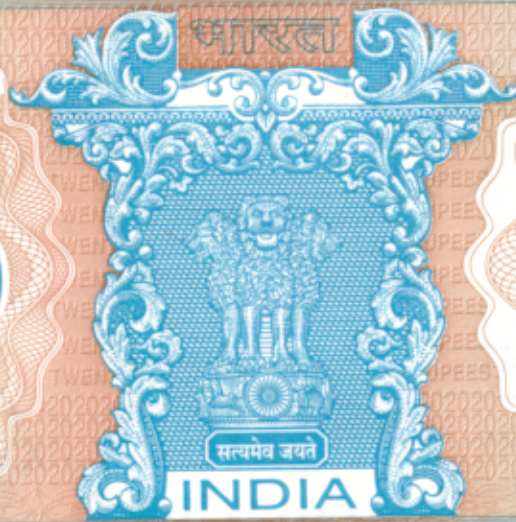

1. In Schedule 5:-

In all schedules if any expenditure on good and services , provided by the political party, or provided by any person / company/firm/associations/body of persons etc. on behalf of the candidate, then the national market value of such goods and services are to be indicated, in respective columns.

3. In part- III the lump –sum amount of fund received from the political party or others or the candidate's own funds , should be mentioned date wise. In all such cases such amounts are required to be first deposited in the bank account of the candidate, opened for election expenses.
