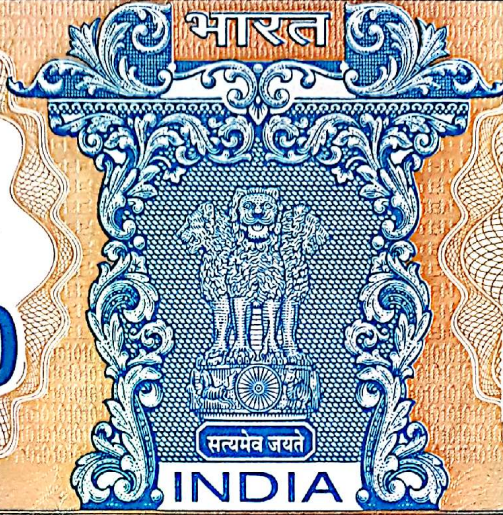

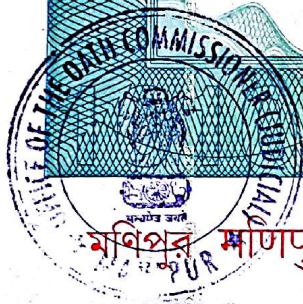
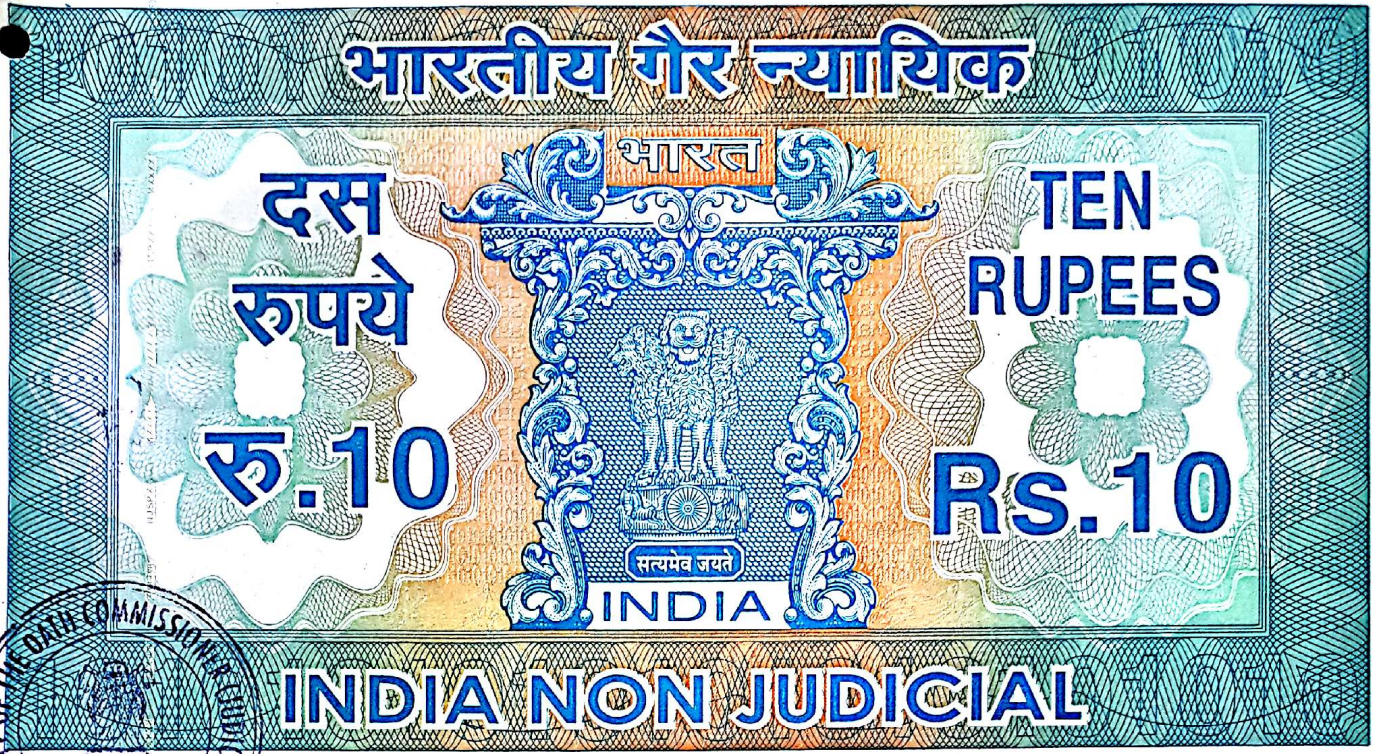

1. In Schedule 5:-
